3. How We Use Information

- Protection of Rights: To safeguard the rights, property, or safety of Rome Invicta (Pty)
 Ltd, our Users, or the public.
- Cross-Border Transfers: Where data is transferred outside South Africa, appropriate safeguards (such as contractual clauses or equivalent protections) will be applied.

5. Data Security

We implement reasonable technical and organizational measures to protect personal data against unauthorized access, loss, or misuse. However, no system is completely secure, and Users acknowledge that they provide data at their own risk.
